Direct Deposit Electronic Payment Request

Stephens Production Company is now offering an electronic funds transfer (ACH) option for its revenue interest owners. This new service is provided for your convenience and at no additional cost to you.

ACH payments are only available for accounts drawn on banks within the United States and for payments less than \$50,000.

Please note, if you elect to receive electronic payments, you will no longer receive check payment detail by mail.

The check detail can be accessed online at <https://secure.OildexDX.com/stephens> . You can set up the option to have your check detail automatically emailed to you through this website.

Please contact Enverus, (formerly known as Oildex), at 1-855-301-5241, and choose the option for Owner Relations Management System to get set up with a login and password.

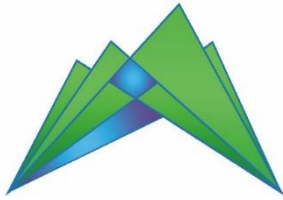
Some of the benefits of ACH include:

Changes in ACH instructions must be received in writing at least 30 days in advance.
